




4. For the children referred to in paragraph 3, the School shall be reimbursed in accordance with the provisions of the Rajasthan Right of Children to Free and Compulsory Education Rules, 2011. To receive such reimbursements the school shall maintain a separate bank account.
5. The Society/School shall not collect any capitation fee and subject the child or his or her parent or guardian to a screening procedure.
6. The School shall not deny admission to any child for lack of proof of age and shall adhere to the provisions of section 15 of the Act of 2009. The School shall ensure:
 - (i). No child admitted to the school shall be held back in any class or expelled from school till the completion of elementary education in the school;
 - (ii). No child shall be subjected to physical punishment or mental harassment;
 - (iii). No child shall be required to pass any Board examination till the completion of elementary education;
 - (iv). Every child completing elementary education shall be awarded a certificate as laid down under rule 23 of the Rajasthan Right of Children to Free and Compulsory Education Rules, 2011;
 - (v). Inclusion of students with disabilities/special needs as per the provisions of the Act of 2009;
 - (vi). The teachers are recruited with minimum qualifications as laid under sub-section (1) of section 23 of the Act of 2009;

Provided that the current teachers who, at the commencement of the Act of 2009 do not possess minimum qualifications, shall acquire such minimum qualifications within a period of 5 years, as per the provisions of the proviso to section 23 of the Act of 2009;

11. The School is run by a society registered under the Societies Registration Act, 1860 (Central Act No. 21 of 1860), the Rajasthan Societies Registration Act, 1958 (Act No. 28 of 1958) or a public trust constituted under any law for the time being in force;
12. The School is not run for profit to any individual, group or association of individuals or any other persons;
13. The accounts should be audited and certified by a Chartered Accountant and proper accounts statements should be prepared.
